Here Are The Issues

The residents of Rensselaerville are disadvantaged relative to other US populations because we lack broadband access (high-speed internet), adequate cellular coverage and may have ongoing public safety communications problems.

Charter

- Assisting to improve public safety agency emergency communications systems (includes DHS/FEMA, fire, EMS, Albany County sheriff, etc.)
- Increasing cellular telephone access to the greatest geographical coverage possible.
- Providing high-speed internet access (“broadband”) to the maximum extent possible to the greatest population at the lowest cost

May Town Board Minutes

The Regular Meeting of the Town Board of the Town of Rensselaerville was held on the 10th day of May, 2007 at the Rensselaerville Town Hall. The Town Board accepted minutes from the last regular meeting, the Town Clerk's monthly report, the Superintendent's report, made transfers, and paid bills.

TOWN OF RENNELLAERVILLE VOLUNTEER HALL OF FAME

Supervisor Nickelsberg spoke about different ways that people can serve their country, in wars, as a policemen, helping your town. We have two special people in this Town who are the first to be inducted into the Rensselaerville Volunteer Hall of Fame. Barry Cooke joined the fire department when he was 17, and ever since he has been doing things for the Town, whether it is in the emergency medical area, the fire department, at his church for his neighbors for 35 years plus. It is people like Barry and Allyn Wright, the second to be inducted tonight. Allyn at the age of 18 joined the fire department and ever since has been volunteering, helping his neighbors for 50 years. Allyn was first with the fire department, the emergency medical effort and most recently in the last 21 years with the Planning Board. Folks like Barry and Allyn have carried the county on their backs with a lot of help from our neighbors and fellow Americans, but this is special, 50 years and 47 years make us very much indebted to you and we respect you tremendously. On behalf of the Board we Thank You both. Supervisor Nickelsberg presented an engraved crystal bowl to both Barry Cooke and Allyn Wright.

CORRESPONDENCE

SENIOR AND YOUTH BUS

Supervisor Nickelsberg mentioned that we received a letter from Senator Breslin mentioned that we will be receiving \$5000.00 in funding for the purchase of the bus, once the paperwork is completed we should get it in about 60 days. Thank you to Mr. Bolte who approached Senator Breslin for help with funding for the bus. Supervisor Nickelsberg mentioned that we have \$13,478.00 toward the purchase price of the bus.

Mr. Bolte mentioned that the Greenville Rotary is going to have bike-a-thon and donate all the money to the bus fund. This event will be May 19th at 12 noon in Greenville. We are looking for riders. He went to the Senior Citizens luncheon in Medusa and they are very excited about this. We think we will raise this whole amount and will pay the Town back.

Letters were received from Valerie and Joel Lounsbury concerning the Senior and Youth Bus and Theron Raines concerning the dust on Kenyon Road.

Is the van different from the 20 seat bus?

Supervisor Nickelsberg, yes, it is different in that we are getting a registered 14 seat bus, we are not taking in all the seat because of the licensing issue. If we had all 20 seats and don't have enough drivers with a special driving permit it would be hard to get it on the road. The idea is to have it on the road as much as possible.

Mr. Cooke, we did this so that anyone could drive the bus with a regular drivers license. We asked the manufacture to hold the number of seats out until such time as we really need them. The bus is going to be certified as a 14 passenger bus when the time comes we take it back and they put the seats in and certify it as a 20 passenger bus.

The Town Board has read this information. Supervisor Nickelsberg, we will make sure that we have people with proper licenses driving the bus, we have an obligation to the senior and juniors. We can't put the town taxpayers at risk and we are not going to. We have volunteers to drive it. If we don't have anyone with a wheel chair we can have a regular driver. Thank you for the input and documentation.

Mr. Cooke mentioned that he went to the motor vehicle office, they mentioned that for 15 passengers and above you have to have a "P" on your driver's license, 14 and under anyone can drive it with or without wheel chairs. The cab, the wheel base is the same as we have now, the only difference is that it sits people side by side instead of back in a row. It also has two handicapped accesses with a ramp.

Councilman Chase, what do you need for training on that for the insurance company, in order for you to drive one of those things you have to be certified by NYS to be able to strap someone in who is in a wheel chair, if you had an accident the town would be liable if the wheel chair wasn't strapped in correctly.

Mr. Cooke asked that of at motor vehicle office, they said there was no training required. You should find this out from your insurance company.

The 20 passenger was leaning towards the us by the kids, the seniors wouldn't have need for this, it would be waste of money using something like that to take one person up to Albany.

Supervisor Nickelsberg, we have the current van which in the ninth inning of it's life, we will keep it until we have to send it back, then we



Public Safety Communications

We plan to solicit feedback from all the local, county and state public safety and communications agencies to better understand any issues or problems they may be having, especially for local fire and EMS companies. Obviously, the town must understand the needs of state police, county sheriff, surrounding communities, DHS/FEMA, etc., as part of our ongoing planning processes for zoning, etc.

Cellular

We are still exploring options for increased cellular access, so nothing new to report there. This will be mostly a function of tier-3 build-out (rural roads coverage) mandated by the FCC and depends on each of the respective cellular telco’s existing coverage and expansion plans. We expect to meet with the four major NE carriers over the next few months to explore their plans and criteria for this mandated expansion. It is doubtful we can achieve 100% coverage due to population density and terrain, but we may be able to significantly increase existing coverage. This is also an important public safety issue.

Internet Access

To facilitate broadband internet access it is apparent we will need to use a hybrid approach of HFC cable, wireless and maybe even other technologies to reach the maximum number of residents, given our “hilltown” geography.

Cable TV (includes also high-speed internet and telephony services over cable)

The recent activity has been regarding the cable upgrade, so the rest of this article will review that project.

The replacement and conversion of the (prior) Milestone analog cable TV head-end into Mid-Hudson Cable’s new digital HFC system is now completed! The cost for the Rensselaerville upgrade was between \$350,000 and \$400,000, and we are the first town in this MHC service area (1,000 miles of cable plant coverage) to receive the upgrade. This project included increasing the cable plant supporting Rensselaerville from 50 miles of cable under Milestone to now 70 miles under MHC.

It is uncommon for cable infrastructure to be converted and expanded in rural areas like ours, let alone so quickly. So far MHC has done well in accommodating Rensselaerville’s needs and they are now starting to upgrade other areas, including Ashland, Cairo, Windham, etc.

We are now examining how to go about extending the reach of this new system and MHC is open to such requests. Unfortunately, that is not as simple as “the guy ½ mile from me has cable, so can I get it, too?” It costs \$22,000 per mile to build additional “reach” so there must be at least 15 homes along that mile (“HPM” or Homes Per mile) that are willing to subscribe to such services before MHC will undertake considering such an extension. The normal rural “HPM” density requirement is 35 subscribers per mile, so the criteria under this new ownership are much more favorable to areas with density like our town. The reason they can do that is because they are offering more than just analog TV like Milestone did.

Also, please bear in mind that just because the existing cable ends at some point may not mean they can extend an additional mile from that exact point. Some of the infrastructure is trunk line (as opposed to distribution line), so the mile distance may not start at that particular point. Such expansions will require a detailed survey and analysis by MHC (under NYPSC guidelines) to determine if it can be accommodated. Besides the construction cost to add additional service area (\$22K/mi), there are many recurring costs (maintenance, personnel, power, insurance, taxes, utility & telephone pole certification, etc.) that factor into the equation. It ends up being primarily an MHC business decision to invest in new infrastructure with a reasonable expectation to amortize that investment over a reasonable time-frame.

Of course if someone (like a homeowner or group of homeowners) is willing to underwrite (pay for) some of the cost for adding infrastructure and there are less than 15 subscriber HPM, they (MHC) might be willing to extend in

a particular direction. Later additional subscribers will also be asked to pay back part of the additional funds paid by the initial subscribers on the new section.

We are also examining additional federal and state grants that may be available to fund the construction of expanding this service coverage. In fact, there were USDA rural connectivity loans taken by MHC to fund the present upgrade and expansion, which must be repaid by MHC over time.

In the near future we expect to have a map posted at the town offices in Medusa so you can see the sections of particular roads currently reached by MHC service.

There is NO service offering for stand-alone high-speed internet service. If you already have satellite TV, MHC does offer a plan for bundled internet access and telephone service. They also offer plans for bundled basic cable & high-speed internet and a combination of all three services (TV/internet/telephone).

Two items I’d like to make any existing subscribers aware of:

In the event a subscriber is without service for over four (4) hours because of an interruption such subscriber shall be rebated a prorated share of his monthly charge for that period of time beyond the first four contiguous (4) (sic) hours he or she is without service, all in accordance with NYPS&C rules.

Complaints received regarding the quality of service, equipment malfunction, billing disputes and other matters, shall be acted upon as soon as possible, but in no case later than the following scheduled business day after receipt. Any matters that cannot be resolved to the satisfaction of the subscribers within three (3) business days of their receipt may be forwarded to the Town Board.



will buy an SUV or something smaller which would be much more appropriate to take people to doctors appointments and things like that.

Keep the van for the kids and get a 5 seater van for the seniors. I hope that you have it mandatory that 3 or 4 mothers go along on the bus with the kids.

Supervisor Nickelsberg, the current van is not handicapped accessible.

For \$57,000 you have to get a lot of people that don't have kids to participate.

Councilwoman Dorman, parental participation that is going to be one of the rules. The cost of the bus is a single item. We want to get more people involved in the Committee, we ask for all interested parents to become involved in the program, it is necessary for parents to become involved. We have had 42 positive answers from people who have children and also positive input to ride along, to supervise and to support the program financially and those people don't have any children and they still want to become involved. All the hamlets are involved. We need the involvement from the parents so we cannot take the kids to these programs, such as, swimming, ice skating, roller skating, etc. We cannot take them unless we have parental supervision. That is our goal. The Committee will meet next Thursday evening there will be a meeting at the Town Hall at 7 PM if anyone is interested

Supervisor Nickelsberg, this is about 95% of the people for this and 5% not for it.

Supervisor Nickelsberg, Mrs. Vogel is the person who does the scheduling for the van, this is a lot of work to schedule drivers to get the people to their destination, use of the van has gone up. We will get a floral arrangement to thank Mrs. Vogel for the excellent job she is doing and will continue to do. Anyone who wants to drive please contact the office.

Albany Transportation, Ravena is busing people up to the doctors, you can call an 800 number to make the arrangements. Please talk to Kathy Hallenbeck.

REPORTS

SUPERVISOR'S REPORT

Supervisor Nickelsberg mentioned the stock market, being strong, helping pay for the pensions of the employees, interest rate are flat, the economy is still growing around 3% here, the cost of high oil price and the cost at the gas pumps is expensive. Our contribution from the County should up to this point be in line or greater than last year. Supervisor Nickelsberg gave the bank balances for each account. The last three CDs are coming up for renewal, we would like to see if we can put it in a jumbo CD and get a better rate.

Attorney Ryan mentioned that you have to keep those funds separate because they are separate reserves.

A motion was made by Councilwoman Dorman to accept the Supervisor's Report, 2nd by Councilwoman Pine. Motion carried unanimously.

HIGHWAY SUPERINTENDENT'S REPORT

Supervisor Nickelsberg read the following report from Superintendent Chase;

I request payment for schooling to attend classes at Ithaca College through the Cornell Roads Program from June 3-6, 2007. There is money in my Highway Account for this.

The Highway Department has been working to restore the washed out roads from the 3 storms in April to useable condition. The worst roads were King Lane, Pond Hill – the upper side, Pearson Road and Pucker Street. It will take a considerable amount of time to complete these projects.

The shoulders have been completed on Niles Road with use of the Albany County shoulder machine.

I have applied for FEMA funding for roads that were damaged due to the 3 storms in April through Albany County.

A motion was made by Councilwoman Dorman to accept Superintendent Chase's Report, 2nd by Councilwoman Pine. Motion carried unanimously.

Councilman Chase had pictures of the damage done to the roads.

OLD BUSINESS

COMMUNICATIONS COMMITTEE

Mr. Urritia mentioned that Mid Tell is aware that we have no cell service in one part of the town, they are interested in what we are doing. Mid Hudson, our cable provider, the upgrade of the cable plant is complete, they are going road by road with cable, they are 50% complete in this area and they are moving people over to the new system as they go along. Once they are complete they will review extending their reach in certain areas. They would like to speak to the committee at that point and look at maps and discuss moving out. They don't unbundled their services. Their basic service is \$22.00, their satellite service is \$40.00 but you can't buy their internet high speed separately this all cost about \$99.00.

Supervisor Nickelsberg mentioned that there is a fellow on Roney road, the cable provider was up on that road and they were going to stop about nine tenths of a mile from his home. He hoped that the Town could persuade them to extend the line, we called them and also had Senator Breslin call them. When and if you know they are on your road and you are trying to get access, it is worth a try. There were 9 homes on that nine tenths of a mile. I think their policy may be 25 homes or something like that per mile.

There was an issues about sketchy service, a resident has signed up with the new system and this resident is satisfied with the system. They are trying to make this transition smoothly and deliver the service. Still they only serve a small portion of our population.

MARIE DERMODY

Marie Dermody read a letter concerning the issue of reinstating the small pay for the Grievance Board. (Complete letter on the web and in local newspapers).

Supervisor Nickelsberg made a motion not to reinstate this line item on the ground that we have faced the issue during the budgeting process, we have agreed and voted on the specific issue at that time. I believe strongly in the excellent leadership shown by the Planning Board, Zoning Board, and the number of other voluntarily participatory efforts on behalf of the Town. We made the judgment based on the fact that people that serve dozens of hours sometimes in a month, the LUC committee, 5000 plus hours in the last ten months and so we had a reason at that time and we have a reason at this time regarding the vote, so I make a motion not to reinstate the line item.

Attorney Ryan, motions have to be in a positive form, not negative.

A motion was made by Councilman Chase to reinstate the line item for the Grievance Board, 2nd by Councilwoman Pine.

A roll call vote was taken with the following results: Supervisor Nickelsberg-NA, Councilman Chase-AYE, Councilwoman Dorman-NA, Councilman Lansing-NA, Councilwoman Pine-AYE

LAND USE COMMITTEE

We are going to move ahead on Tuesday with the Land Use Committee, we want to increase the committee from the current 11 to 13 members. We would like to included Randy Bates and Barbara Lippert on that committee. After talking with Mr. Mikulka and Mr. Wright among others we realized that it might be best to have that first meeting with everybody, the Town Board on Tuesday as opposed to just the LUC committee and then have a meeting subsequent with the LUC committee and the Town Board. I would like to do this at the Town Hall, 7 PM the Town Board and the reconstituted LUC committee.

Councilman Chase asked if we had taken a motion in the past that limits the board number.

Supervisor Nickelsberg, we are at 13.

A motion was made by Supervisor Nickelsberg to add Randy Bates and Barbara Lippert to the Land Use Committee, 2nd by Councilwoman Dorman. Motion carried unanimously.

ZONING & SUBDIVISION LAWS

Attorney Ryan mentioned that we had a hearing on April 18th, we now need to vote on the zoning and subdivision regulations. We did make a motion to extend the Moratorium for 6 months on May 1st after a public hearing. Attorney Ryan explained about the public notice and posting of the notice.

A motion was made by Councilwoman Pine that we adopt Local Law # 2 of 2007, Titled "Subdivision regulations of the Town of Rensselaerville".

No second. Motion not carried.

5 MINUTE SPEAKING RULE

Supervisor Nickelsberg mentioned that we are going to have a 5 minutes speaking time in the audience comments from this point forward. We are not going to have a resolution because if we need to not have it or if we break out shouting that we had in the past we will have to eliminate it. The easiest way is to cease having the audience comments. I am here between 20 to 7 to 5 to 7 PM on Town Board Meeting nights, this time is open for comment or have a discussion on anything in the Town. Audience comments will last as long as we need to get them done.

Howard James mentioned that the audience comments discussion goes back to October of last year, you made a comments that if you have something to say you have 3 minutes to do so. Then it went to 2 minutes. It was mentioned that 2 minutes is a disservice to the public, I went to the meeting on the Feb 8th and you gave us 5 minutes to speak. Audience comments are not addressed by NYS Law and it is up to the Supervisor or the next supervisor's. If they want to take away audience comments it is in his hands not in the Town Board hands. What I want to do is make a proposal that somebody who believes in the first amendment of the constitution of the United States to make a proposal to have a resolution that be it five minutes, four minutes, two minutes. The main this is grandfather in audience comments, don't leave it in the hands of one person. Freedom of speech is our most valuable tool, if we lose that we lose everything.

Attorney Ryan mentioned that the gentlemen who spoke is correct about this. Bob Freeman who knows everything about the open meeting law, and public officers law has written extensively on this. There is no provision in the Town Law providing for audience comments at town board meetings. It is solely at the discretion of the Board. It is up to the Town Board.

Councilman Chase, do other Towns do this.

Attorney Ryan, it depends on the Town and what the members of the Town Board wants.

Councilwoman Dorman, I think we should thin about it, it is reasonable and we should sit at a work meeting and discuss it before we make a decision.

ROAD AGREEMENT

Attorney Ryan mentioned that in December and January he had circulated a road agreement from Superintendent Chase, this needs to be signed. The agreement in front of you is the same agreement that you had in December and January with the exception that the Supervisor wanted the priority done by the roads. Subdivision G was added on page 4 for the order of the roads. Cheese Hill Road, Kenyon Road, Travis Hill Road, Dapice Lane, Smith Road and Knowles Road. The secondary list is, Siebert Road, Gifford Hollow Road, Cooke Lane, Bates Hollow Road and Jaycox Road. The Town Board needs to sign this agreement.

A motion was made by Councilman Chase to adopt this Highway Agreement, 2nd by Councilwoman Pine. Motion carried unanimously.

The assignment of roads, is it in any specific order.

It is in the order that we read off.

NEW BUSINESS

PARKING SPACE FOR HANDICAPPED AT RENSSELAERVILLE LIBRARY

Councilwoman Dorman mentioned that the Rensselaerville Library had a request from a citizen that she would like to see reserved parking space for the handicapped in front of the Library. There is a cut out access from the street to the Library. You should consider if a handicapped space is put in front of the Library that space will have to remain open and there is serious parking problem in Main Street in Rensselaerville. There is one side of the street parking.

Councilwoman Pine, does this have to be a permanent parking or just put cones up while the Library is open.

Councilwoman Dorman, this person is looking for permanent parking.

There is no legal handicapped parking in front of the Library.

Attorney Ryan will check to see how you make a handicapped parking spot permanent and he will get back to the Town Board.

GANGI SUBDIVISION

Attorney Ryan asked to see the subdivision map that was bought up at the last Planning Board meeting. Mrs. Gangi gave to Attorney Ryan the papers from the bank.

Councilwoman Pine, you are going to tear down the old house are you going to put the two parcels back together.

No, they are going to stay two lots.

Attorney Ryan, is the 7.12 acres going to remain subdivided and not merged with the other lot after you get the house built.

Mrs. Gangi it is going to remain subdivided. Mrs. Gangi explained the layout of the land. From the 105 acres we are taking 7.12 acres off.

Attorney Ryan, who is going to be the owners of the 7.12 acres and who is going to be the owner of title of the remaining land.

Mrs. Gangi, I will be the title holder of both parcels.

Attorney Ryan would like the record to reflect that because the moratorium local law doesn't provide for applicants to obtain a variance from that moratorium by making a presentation to the Town Board and then having the Town Board vote on it. For the Town Boards sake I would like to see a copy of the new mortgage commitment and a copy of the map.

A motion was made by Councilman Chase to wave moratorium requirements on this subdivision a hardship. All the filing requirements under the Town Law, that all the necessary paper work, mylar, stamped mylar, two deed descriptions, for the 71.2 and remaining 96 acres be given to the Town Attorney, 2nd by Councilwoman Pine. Motion carried unanimously.

TOWN BOARD SALARIES TO LIBRARY

Supervisor Nickelsberg mentioned that at the work meeting we had a discussion concerning the recent tragedies in the Hamlet of Rensselaerville to eliminate the supervisor and towns board salaries for the balance of the year and redistribute it to the Library and other organizations that were hard hit. Three of us said yes and two said no. We will table this until the next meeting and see what happens and what needs to be done.

Councilwoman Dorman, I would make a plea to the general public to have some kindness in your hearts and perhaps give a small contribution if possible to the Library so that we don't have to shut it down. We are tied up, we can't balance our books, we can't pay salaries until we raise some money. We can't get into our checking accounts, everything has been confiscated. If anyone can give us a donation we would greatly appreciate it.

Have you checked into the Middleburgh Library District to see if they can help out.

Councilwoman Dorman, we will do this.

It was noted that some people may not know what has happened.

Councilwoman Dorman reported that the Library has been embezzled, the President of the Library Board took every cent that we had and also from the Episcopal Church Vestry and the funds from the Rensselaerville Historical Society and the Rensselaerville Historical District Association. Councilwoman Dorman explained what has happened with this person and also how the investigation started.

Is it possible to set up some kind of ad hock Friends of the Library or something, so that another organization can pick up the operation of the Library.

The Library has a Friends of the Library Association, and some of the people that come and work in the Library or throw a fund raiser, we have always operated on private funds. We depended on contributions. We have movies for the kids, we have festivities at Christmas time, these are small dollars, if anyone is interested give me a call or donate to the Rensselaerville Library. We are opening a small temporary account so we can pay our bills.

Councilwoman Dorman answered all the questions from the audience concerning the matter of the missing funds and the person who has been named doing the larceny.

FEMA

FEMA will be holding a meeting on May 15th relative to the process, Albany County has been put in the category as a potential recipient for funding for the floods that occurred in the last 45 days. We are going to have a team go to the meeting on the 15th and try and get additional money for the roads, the parks and other things that have been impacted one way or the other due to the water and runoff damage.

SUPERINTENDENT'S SCHOOLING – JUNE 3 – 6, 2007

Supervisor Nickelsberg, concerning the authorization to attend the meeting and the reimbursement for the Highway Superintendent. We addressed that issue during the budgeting process, with all the past schooling that the superintendent has been to at Cornell Extension be put into priority relative to the building of the roads, and we voted on it during the budgeting process. We voted against this trip and we can do so again if that is where we are.

Councilwoman Dorman, we have already voted on it.

Councilwoman Pine, during the work meeting you said he wanted to be reimbursed out of the general fund according to his report which we accepted he is taking this out of his highway fund. The money is there.

Supervisor Nickelsberg, it is up to us to vote on whether or not that is going to happen and we spend that money on that item as opposed to roads.

Councilman Chase, that doesn't have to do with roads, it is his contractual.

Councilwoman Pine, we also pay dues to the organization that he is going to for schooling.

Supervisor Nickelsberg, that is fine and we get publications for that and we can call them for advise, and we do, I assume, and so basically we are very interested in him building ten year roads.

ZONING BOARD OF APPEALS

We have received a resignation letter from William Whitbeck, Chairman of the Zoning Board of Appeals.

We will be getting another resignation from Mr. Watkins who is moving from the area. We have some ideas, Mr. Whitbeck suggested Jim Glorioso who has done some great work on the Land Use Committee. We will address this and make a decision very soon.

A motion was made by Councilwoman Dorman to accept the resignation of William Whitbeck, Chairman of the Zoning Board of Appeals, 2nd by Councilwoman Pine. Motioned carried unanimously.

AUDIENCE COMMENTS

Marie Dermody, did you ever wind up with a resolution regarding the reimbursement of the Town for the monies that have been funded for the senior and youth van, this was in the March minutes that a resolution would be written up.

Attorney Ryan advised them that the Town can't solicit money but other people can solicit money and then make a gift to the town of the money that is given to it.

Marie Dermody, the March minutes mentioned that Attorney Neidl will prepare a written resolution for the reimbursement of the money raised to go back to the Town.

Attorney Ryan will follow up on it and do it.

Marie Dermody, the only other comments I am going to say and from here on in it is a dead issue regarding the Board of Assessment Review, you may of won the battle but you certainly haven't won the war.

Mr. Hurley, I am trying to get a handle on what is going on, you people make a motion, second it and pass it, the people out here are just observers, they don't vote.

Land Use Committee

The Land Use Committee (LUC) met again on May 15th in a joint session with the Town Board. The purpose was to set goals for the completion of the review and revision of the Zoning and Subdivision Regulations, The need to provide opportunities for more public input and education was also a main topic of discussion. As a result, LUC is seeking comments and questions on Version 2 of the Zoning and Subdivision regulations. There is an Old Zoning and New Draft Zoning Comparison on the website at www.rensselaerville.com to see the changes. Weekly meetings are at 7:00 PM every Tuesday at the Town Hall. Public comments are welcomed at the end of the meeting. Comments can also be mailed to the Town Hall, c/o LUC, 87 Barger Road, Medusa, NY 12120 or can be sent electronically to the following e-mail address planningboard@rensselaerville.com. Future editions of the Newsletter will feature answers to the questions received.

In addition there will be three question and answers sessions on June 12th at the Rensselaerville Firehouse at 7:00 PM, June 26th at the Tri-Village Firehouse at 7:00 PM, and July 10th at the Town Hall at 7:00PM. Each will be held in a different hamlet, but all the citizens of Rensselaerville are encouraged to attend regardless of the location.

The members also voted 12 to 2 in favor of re-establishing the Agricultural District minimum acreage to 5 acres.



Mohawk Hudson Land Conservancy

On Saturday, March 24th, Andrew and Carolina Ward generously hosted a small gathering at their home to introduce some of their friends and neighbors to the Mohawk Hudson Land Conservancy (the "MHLC"). Jill Knapp, the Executive Director of the MHLC explained what a conservation easement is.

A conservation easement is a legal agreement between a landowner and a land trust (like the MHLC) that permanently limits uses of land in order to protect conserva-


tion values (such as wild habitats, natural forests, bodies of water, or farmland). The landowner decides what parts of their land they want to preserved and what the restrictions should be. The landowner continues to own and use the land and can sell it or pass it on to their heirs. Future owners are bound by the terms of the easement. Easements do not permit access to the property unless the owner wishes.

People execute conservation easements because they want to maintain scenic beauty of their commu-

nity and protect it from inappropriate development. Although an easement may lessen the value of a parcel, there can be a substantial Federal and State tax savings. Placing an easement may also result in a lowering of real estate and estate taxes. Anyone interested in granting an easement should consult their attorney or accountant.


